Biography:

In 1839 Scottish immigrant James Graham overlanded from Sydney to Melbourne to open a Melbourne agency for S.A. Donaldson, a Sydney merchant. Successful in colonial commerce, Graham was in business on his own account by 1841. Graham, Lamb & Co. was formed in 1853, but was dissolved in 1858 in favour of the family firm of Graham Brothers & Co., which became one of the colony's notable firms. James Graham's wider career included directorships of railway and insurance companies, pastoral interests and an undistinguished term as a Member of the Victorian Legislative Council. The family became prominent in other fields of Victorian economic development: the firm's interests were reduced to those of managing accountants.

Scope and Content of Series

Notebooks; legal papers; financial papers; correspondence; papers regarding John Capel's run; government publications. The papers listed relate to the administration of John Capel's will, for which James Graham and a Dr. Richard Youl were joint executors. Capel occupied a run 'Gonn' (parts of which was leased originally as 'Noorong' and 'Mooroomgatta') on the northern bank of the Murray River near the Loddon junction from the late 1840s. During the 1860s and 1870s he began to buy parcels of land and with the aid of well placed friends attempted to prevent selectors and public reserves encroaching on the holdings. On Capel's death in March 1877, his estate was sold and divided between his six brothers and sisters and a trust for his dead brother Daniel's four daughters. The trust was finally wound up in 1921.
