HISTORICAL NOTE	James William Barrett was born at Emerald Hill (South Melbourne) 27 February 1862, the eldest of eight children to James Barrett, physician and Catherine <i>née</i> Edkins. Barrett was educated first at a private elementary school and later at Melbourne Grammar and Carlton College where he matriculated dux in 1876. Barrett entered the University of Melbourne where he completed a Bachelor of Medicine (1881), Bachelor of Surgery (1882) and served as a Resident Medical Officer at Melbourne Hospital. Proceeding to King's College, London, Barrett continued his studies, gaining Membership to the Royal College of Surgeons (MRCS) (1884) and Fellowship of the Royal College of Surgeons (FRCS) (1887). Upon his return to Melbourne Barrett gained a Doctor of Medicine (1887) and Master of Surgery (1888) from the University of Melbourne; held the position of Demonstrator in Physiology and Histology at the University until 1897 when he was appointed an honorary Lecturer in the Physiology of the Special Senses. He was also Assistant Surgeon and later Surgeon at the Victorian Eye and Ear Hospital (1893–1913), thereafter serving as Ophthalmologist at the Melbourne Hospital as well as operating a private practice. In 1901 Barrett became a member of the University of Melbourne Council and was appointed joint Secretary of a Committee to advise on the reorganisation of the University of Melbourne in the areas of administration and education.
