HISTORICAL NOTE	The firm began in 1859 with Stanislaus Bayly, first town clerk of Port Fairy, who built a bluestone office, complete with strongroom, at 6 Princes St and conducted a legal practice there. He took William Powling into the firm and Powling qualified to practice in 1869. After Bayly's death in 1876 Powling bought the premises and three generations of Powlings ran the business from the same address until it was taken over by J.S. Tait & Co. of Warrnambool in 1981.
DESCRIPTION	Extensive legal collection of a regional legal practice, including records to 1940, containing drafts, correspondence, accounts and letter books
NOTE ON COLLECTIONS	Damaged and in poor condition, collected on site and sequence lost, indexes missing or misplaced

NOTE ON LISTING

While the filing of client material appeared to be based on legal processes, this formality appeared to change, either with the generations or the extent of work for particular clients, as some files became isolated [such as wills, estates]. The documents appear to have been regularly indexed and bundled, but the poor conditions of subsequent storage [leading to water and vermin damage, and collapse of bundles], together with a disordered transfer process to the Archive, resulted in many apparently isolated documents, which may or may not have been filed by process. Sorting the material to reassemble documents relative to legal process [which appears to have been used] was not possible. The cataloguing of the collection was almost complete when a further 4 lineal metres of records were deposited with the Archive.

Some of the series have their own index, while others [wills, probates, agreements, etc] have separate indexes. A number of the series documents have been listed noting the principal parties, so that some documents relevant to particular individuals or companies may be found by a computer search. Many documents [particularly those relating to frequent legal process, such as mortgage, transfers, agreements, leases, powers of attorney, for example] are not separately itemized by the parties named within.
