**HISTORICAL
NOTE:** Born in England on 26 January 1912, Norman Rothfield began his political life in 1934, when he was elected a Labour councilor in the London borough of Marylebone. In 1938 he migrated to Australia and in 1941 he became a member of the Australian Labor Party. In 1942 he was appointed to the executive of the Jewish Council to Combat Fascism and Anti-Semitism, of which he became president in 1947. In the same year he assumed the role of chairman of the public relations committee of the Victorian Jewish Board of Deputies. During the next five decades of ongoing political activism, Rothfield became a foundation member of the Jewish Radical Association, the Fabian Society, Friends of Peace Now, and the Australian Jewish Democratic Society (AJDS). For twelve years, between 1974 and 1986, he became best known for his association with the political journal 'Paths to Peace', which he and his wife, Evelyn, published. Rothfield remains actively involved in the AJDS.

**NOTE ON
COLLECTIONS:**

Series 1-3: The Executive Council of Australian Jewry was the official organization of Australian Jewry and was constituted by State-based Jewish Boards of Deputies or Advisory Boards. In Victoria, the Victorian Jewish Board of Deputies acted as an umbrella organization to which other Jewish organizations were affiliated. One such organization was the Jewish Council to Combat Fascism and Anti-Semitism, of

which Rothfield was the Chairman. He was also the Chairman of the Public Relations Committee of the Board of Deputies, which was established to represent Jewish interests in the broader community.

However, in 1952, the Jewish Council to Combat Fascism and Anti-Semitism withdrew its affiliation to the Victorian Jewish Board of Deputies and became an independent organization.

Series 5: Paths to Peace is closely related to Series 7: 3CR. Paths to Peace ran a long campaign to have a progressive, pro-Israeli voice heard on the community radio station 3CR, which was perceived to be extremely pro-Palestinian and anti-Israeli. Both series contain material relating to this dispute, though the bulk of it is contained in Series 7. One of Paths to Peace's central activities was the publication of a journal of the same name, copies of which are to be found in Series 20: Publications & Theses.

Series 6: The Australian Jewish Democratic Society was established in 1984 to support activities for peace and nuclear disarmament, promotion of peace in the Middle East, tolerance and harmony between ethnic communities in Australia and to support Aboriginal (land) rights.

The provenance of the material collected in Series 12/17, the Vietnam War, is mixed. While Norman Rothfield was involved in the anti-Vietnam War movement and did collect some of this material, his son Jonathon Rothfield worked for a time as a researcher for Dr Jim Cairns and the bulk of this material was collected by him in that capacity. Titles given to folders listed in Series 15 & 19 derive from the first or most prominent item in the files
