HISTORICAL NOTE:

The Australian Public Service Artisans' Association (APSAA) was formed in Melbourne in late 1915 by skilled tradesmen employed by the General Post Office. Motivated by a sense of the importance of their skills and the nature of government employment, these men rejected overtures to join the general postal workers' union and instead determined to establish an independent union.

War had precipitated major changes to the Australian economy, leading to rapid economic growth and a significant diversification in industrial effort and output. Many new industries were established, many with considerable government involvement or assistance.

These were also years in which unionism spread through the Australian government workforce. During this period public service clerical unions began to organize with some success, while new craft-based unions of government employees such as the APSAA were matched by the formation of unions of supervisory staff such as the Commonwealth Foremen's Association, registered in New South Wales in 1916.

Within years of its establishment, the APSAA began to organize government artisans in departments and agencies well beyond the GPO, meeting with considerable success. In order to consolidate these gains and to specify its areas of recruitment, the union successfully sought Federal registration in 1920. The union also changed its title to the Commonwealth Public Service Artisans' Association, both in recognition of its geographical expansion and its extended representation among Federal departments and enterprises.

Following the Second World War its title was again amended slightly to the Australian Public Service Artisan's Association. Following a period of active negotiations, the APSAA merged with ADSTE in 1986.
