HISTORICAL NOTE:

The AFULE Victorian Division is the oldest continuous railway union in the world. The union formed as the Locomotive Engine Drivers' Association in 1861, became The Locomotive Engine Drivers & Firemen's Association (or Melbourne Enginedrivers & Firemen's Association) of Victoria, when firemen were admitted in the 1870s. It changed its name again to the Victorian Locomotive Engine Drivers', Firemen's and Cleaners' Association when cleaners were admitted in 1902. The union became the Victorian Division of the AFULE when all state locomotive unions federated in 1920 to form a single union. ¹

In the 1890's the Union was conservative and aloof from other railway unions and the union movement in general. It gave up its affiliation to the Trades Hall Council in 1890. The new century brought new political and economic conditions which directly affected the union. A long drought led to economic hardship, a change of government in Victoria and a wage cut for government employees including Locomotive Enginemen. The union drew closer to the Trades Hall Council and applied to re-affiliate in 1902.

The new Premier of Victoria, William Hill Irvine, denounced the affiliation of government employees to 'political' bodies and insisted that all railway unions withdraw from the THC. This confrontation precipitated a strike of Locomotive Enginemen which lasted from 8 to 15 May 1903, during which the strike breaking Loyalist Engine Drivers, Firemen & Employees' Association was formed. The Executive Officers of the Locomotive Enginemen's Union called the strike off after one week when threatened with Irvine's Strike Suppression Bill and lack of public support, even though strikers themselves were keen to continue. It was 1935 before the AFULE Victorian Division finally re-affiliated to the THC.

Other milestones in the union's history were the building of Locomotive Hall in North Melbourne in 1914 which served as the offices of both the Victorian and Federal Divisions, and as an active theatre.

The Victorian Locomotive Enginemen were also supporters of Federation with other state Locomotive Enginemen's Unions, and were represented at the 1899 and 1900 conferences at which the Federated Railway Locomotive Enginemen's Association of Australia was formed. This body met yearly and was the forerunner of the AFULE which took over in 1920.

NOTE ON THE COLLECTION:

The records in the 1996 transfer were held together in the safe at the AFULE Victorian Division office. They consist of the Minute books and related records of the Central Branch of the AFULE Victorian Division, as well as legal records of the Victorian Division itself which the union officials seem to have considered vital. They were collected and part listed by Mr Norman De Pomeroy before transfer to the University of Melbourne Archives.

There is no original classification scheme or record keeping system evident for these records. Consequently they have been arranged by the archivist, and related records in previous accessions have been noted in the description of each series.

Although the AFULE Victorian Division traces its history to the formation of the Locomotive Engine Drivers' Association in 1861, there are no records for the early period in either this or previous accessions. The remaining records date from the twentieth century, beginning with a small number of documents on the 1903 strike. The AFULE Federal Division Collection should also be consulted for Victorian Division involvement at the national level, beginning with their involvement in Federal Conferences from 1899.
