| HISTORICAL NOTE | Drug Houses of Australia Ltd. (D.H.A.) was formed in 1930 (registered in Melbourne in 1929). The company was an amalgamation of a number of leading pharmaceutical companies at that time. D.H.A. Ltd. existed as a holding company for 5 Associated (Trading) Houses in 5 States. The Associated (Trading) houses were: A.M. Bickford & Sons Ltd., Adelaide and Brisbane; Elliotts & Australian Drug Pty. Ltd., Sydney; Felton, Grimwade & Duerdins Ltd., Melbourne; Felton, Grimwade & Bickford Ltd., Perth; Taylors, Elliotts & Australian Drug Pty. Ltd., Brisbane, Rockhampton and Townsville. It took 21 years for complete amalgamation of seven companies, including the companies above, and J. Bosisto & Co. Pty. Ltd., under the D.H.A. Ltd. label. (see J.R. Poynter, pp.161-3). D.H.A. Ltd. continued to expand as a pharmaceutical maker and distributor until the late 1960s. In late 1968 D.H.A. Ltd. was taken over by Slater, Walker Security Ltd. and was ASX delisted from 7 May 1969. It operated as a Slater Walker Australia (SWA) subsidiary, DHA Pharmaceuticals Pty. Ltd., until 1974, when SWA phased out its wholesaling activities, which had been loss making for some years.
