| <b>HISTORICAL NOTE</b>    | <p>This was a small craft union established in individual states in the nineteenth century which amalgamated to form the Federated Felt Hatting Employees' Union of Australasia in 1912 in order to register under the Conciliation and Arbitration Act of 1904. Thereafter, it maintained a strongly federal structure with the state branches concerned with membership and state matters while the Federal Office attended to industrial matters throughout Australia, but in reality in South Australia, Victoria and NSW where the industry was strongest. For many years the Federal Office and the General Secretary were stationed in Melbourne at the Trades Hall, but in the 1960s it moved to Sydney and most of the records of the Union (Victorian, NSW and Federal Branches) were transferred there with the General Secretary.</p> <p>The Union eventually grew smaller in the 1960s and 1970s due to competition from imported hats, mechanization and fashion changes in which men gave up wearing hats. It eventually amalgamated with the Australian Textile Workers' Union in 1984.</p> |

| <b>NOTE ON COLLECTIONS</b> | <p>The records in this collection were transferred to University of Melbourne Archives in 1982 by Mr. K. Cashman, General Secretary of the Federal Union office in Sydney. The records include a small amount from the Federal Branch of the Union, but the majority of records are from the NSW Branch. The overlap has occurred because for some years in the late 1960s Mr. W. Peters, Secretary of the NSW Branch, was also General Secretary of the Federal Union and the records previously held in the Federal and Victorian Office at Victorian Trades Hall were transferred to NSW. The records transferred to Archives in 1982 also contain files created by Mr. Peters as Labor MLC in the NSW Parliament.</p> <p>A previous accession of records of the Federal, Victorian and NSW Branches of the Federated Felt Hatting Employees' Union was sent to the Noel Butlin Archives Centre in the ANU in the 1964/65. The Union had apparently lost sight of these previous records at the time they agreed to deposit others with the University of Melbourne Archives.</p> <p>Researchers should consult records held at both repositories for complementary records.</p> |
