HISTORICAL NOTE:	<p>On 21 Jul 1864 Isaac Hallenstein acquired the Footscray Tannery from the Cleghorn family and two years later, on 17 Nov 1866 he entered into partnership with his uncle Moritz Michaelis under the style of Michaelis, Hallenstein & Co. The partnership re-formed as a limited liability company registered 16 Jun 1892 with all “partners and sub-partners taking up the whole of the share capital”. With the exception of the Sydney & Dunedin businesses (which remained with the old firm) the new company took over the undertaking of the old partnership from 1 Jul 1891. But, as the minutes record, the business was virtually a private company and steps were begun in Mar 1897 to convert it to a proprietary company. This happened in about May 1897. The company operated tanneries in Melbourne, Sydney, Perth & Dunedin and the business handled leather, grindery, saddlery, canvas, sports goods and other lines with other subsidiary factories making finished goods in those descriptions. An office in London also operated as a buying house for all members of the group. The business was reformed as Michaelis Bayley Ltd.</p>
