Born in Colac on 20 January 1872, Henry Arthur Pitt was the fifth of eight children of Mark and Kate Pitt. Mark Pitt, a rural school teacher and the main educational influence on Henry, died in 1889. The financial repercussions of his death forced Henry to abandon his plans to study law. Moving to Melbourne, he entered the Victorian Public Service, thereby gaining an income enabling him to support his younger twin brothers through school and university. On April 5, 1899 he married Gertrude Augusta "Plum" Buxton, eldest daughter of J.R. Buxton, the South Melbourne real estate agent. Gertrude and Henry had four children, Lorna, Kathleen, John and Kevin. Having worked for ten years as clerk of courts in Omeo, Henry was, in 1909, promoted to the State Treasury. Studying accountancy in his spare time, he progressed steadily through the Department's ranks. His hard work was rewarded in 1914 with a trip to London to assist the Victorian Agent-General. In 1916 he was appointed Manager of the Australian Wheat Board, a position he held until 1922, and in the following year was made Under Treasurer of Victoria, later to be re-titled, Director of Finance. For a brief period in 1927 Pitt returned to London, this time serving as Agent-General for Victoria. In 1935 he was appointed to the Royal Commission into Australia's `monetary and financial systems', and on 1 September 1937, he retired from the Public Service. Remaining active long after his retirement, Pitt became a partner in the stockbroking firm of Ian Potter & Co. and continued his work as the President of the Lawn Tennis Association of Victoria (1937 - 1955) and Vice-President of the Lawn Tennis Association of Australia. He also became a member and later Chairman of the board of directors of Georges Ltd., served on finance committees of the Royal Children's Hospital and University College and, during World War II, was Chairman of the War Workers' Housing Trust. On 3 August, 1955, Henry Arthur Pitt, C.M.G., O.B.E. died aged 83.

NOTE ON COLLECTIONS:

While small (occupying only one archive box) and sadly incomplete, this collection provides a sketch of an important public life; one involved in making nationally significant economic decisions during the Great Depression. It also affords researchers an insight into the family history of Kathleen Fitzpatrick (H.A. Pitt's daughter), whose papers also reside at Melbourne University Archives, and forms an interesting link with the Archives' J.R. Buxton Pty Ltd collection.

SERIES 1

CORRESPONDENCE

The correspondence divides into four roughly distinct subject areas. The first relates to Pitt's time as Director of Finance of the State of Victoria, the second to his efforts during World War II, the third to his involvement with the Lawn Tennis Associations of Victoria & Australia, and the fourth with miscellaneous activities.

1/1 Director of Finance Correspondence

N.B. Unfortunately there is only one surviving letter written during the time Pitt was Director of Finance for Victoria.

1/1/1 1931

Addressed to `Dear Bubbles', who was living in London but was about to move to Milan, the bulk of the letter forms an account of Pitt's involvement in a Canberra meeting of State Treasurers and their top officials. Due to present a report to the Commonwealth on the state of the country's economy, there was much debate as to whether it should be limited to statistics or could include more interpretative analysis and policy suggestions. Pitt argued for the expanded version and describes how he manipulated the situation to eventually succeed in having the policy suggestions presented. In the course of the letter he mentions national figures such as Hogan, Lang, Theodore and Scullin, who he describes as `a bit of a fathead'.

1/2 World War II Correspondence

These letters all relate to Pitt's repeated offer to donate money and services to the war effort. The outward letters are in the form of pink, carbon copies, while the inward ones are either typed or handwritten originals.

1/2/1 Outward World War II Correspondence

1/2/1/1 21 June 1940

Addressed to The Right Honourable R.G. Menzies, P.C.

Pitt offers to volunteer his services to war effort and outlines his credentials as follows - Manager of the Australian Wheat Board during W.W.I; ex-Director of Finance, Victoria; Chairman of Directors of 'prosperous trading Company'; and Director of proprietary Company.

1/2/1/2 19 June 1941

Addressed to The Right Honourable R.G. Menzies, P.M.

Pitt suggests the retirement age for men should be extended from 60 to 65, so as to fully utilise available manpower for the war effort. `The modern man is as hale and hearty at 65 as his predecessor was at 60 . .'

1/2/1/3 27 June 1944

Addressed to The Honourable J.B. Chifley, Treasurer

A note from Pitt to accompany a cheque for 500 pounds, `towards cost of prosecuting war'.

1/2/2 <u>Inward World War II Correspondence</u>

NB. The following letters are addressed to H.A. Pitt Esq. Ian Potter & Co.

1/2/2/1 25 June 1940

From R.G. Menzies (Prime Minister), acknowledging Pitt's offer to volunteer his services to the Commonwealth.

1/2/2/2 7 November 1940

From J.B. Chifley (Treasurer), thanking Pitt for his letter of congratulation (not in Collection). Chifley also refers to Pitt's appointment to the Power Alcohol Committee and briefly discusses the beauty of begonias.

1/2/2/3 18 June 1942

From J.B. Chifley (Treasurer), in recognition of Pitt's donation of 500 pounds `to help provide the necessary funds for financing the war'.

1/2/2/4 1 July 1944

From J.B. Chifley (Treasurer), acknowledging another gift of 500 pounds towards the war effort. Official receipt attached.

1/2/2/5 14 July 1945

From J.B. Chifley (Treasurer), apologising for not having earlier acknowledged another gift of 500 pounds.

1/2/2/6 Date Unknown

From A.W. Fadden (Treasurer), in recognition of Pitt's gift of 325 pounds towards 'the cost of the conduct of the war for one minute'.

1/2/2/7 27 June 1946

Official receipt for 500 pounds, donated by Pitt `towards cost of winning war'.

1/2/2/8 10 July 1946

Handwritten note from J.B. Chifley (Prime Minister), thanking Pitt for his `generous donation towards winning the war' and the help he had given the Government and Chifley personally `in connection with the War Workers Housing Trust'.

1/3 Correspondence Relating to Tennis

This correspondence, both inward and outward, deals with matters concerning Pitt in his capacity as the President of the Lawn Tennis Association of Victoria (L.T.A.V.) and his representation of W.A. (despite not living there) on the National Council, i.e. L.T.A.A.

Addressed to Dr. Russell Kingman

Pitt writes to reassure Kingman that the behaviour of Art Larsen, an American playing in the N.S.W. and Victorian State Championships, was not as bad as reported and should not jeopardise his chances of playing in the Davis Cup.

1/3/1/2 Date Unknown

Addressed to The Editor

"World Tennis"

New York, U.S.A.

Pitt writes to contradict Larsen's account of his experiences of playing in Australia. As with his letter to Kingman, he cites Larsen's war history as a reason for leniency, but confesses that his `last trace of sympathy' vanished when he read Larsen's false account of events at the Australian Championships.

1/3/1/3 22 June 1954

Addressed to Judge Walker

President, Western Australian Lawn Tennis Association,

Perth, W.A.

Re appointment of State delegates to National Council of L.T.A.A., suggesting that he would not stand as W.A. representative.

1/3/1/4 29 September 1954

Addressed to Roy Youdale

L.T.A.A. Office of the London Representative, London

Pitt writes to explain his absence from the L.T.A.A. Council i.e. that it was no longer considered appropriate for a non-resident of W.A. to represent the State at the national level. He also mentions that his daughter, Kathleen Fitzpatrick, `- the Professor - is in Italy at the

present time. With a Carnegie Grant she went over to U.S.A. to do some literary work . . . '

1/3/2 <u>Inward Tennis Related Correspondence</u>

1/3/2/1 16 June 1954

From Judge J.L. Walker

Advising Pitt of the W.A.L.T.A.'s decision to `as soon as possible procure that our delegates on the Council of the L.T.A.A. are persons now residing in Melbourne who formerly lived in, and were directly interested in Tennis as played in Western Australia...'

1/3/2/2 29 June 1954

From Roy Youdale - L.T.A.A. Office of the London Representative

This is the letter Pitt is responding to in 1/3/1/4. Youdale expresses his surprise at Pitt's absence from the L.T.A.A. Council and shares Sir Norman Brookes' (L.T.A.A. President) sentiments in congratulating him `on long and outstanding service to tennis in Australia.'

1/3/2/3 23 July 1954

From Donald Ferguson

Re Pitt's resignation from L.T.A.A. Council.

1/4 Miscellaneous Correspondence

1/4/1 21 November 1947

Humorous letter from unknown (the signature is unclear) official of the Commonwealth Taxation Office, Melbourne, in response to Pitt's letter dated 12 November 1947 (not in Collection) that accompanied cheque for 8,857 pounds in taxation payments.

1/4/2 28 February 1952

From Pitt to W.T.W. Ballantyne

c/- United Kingdom Ministry of Supply

Re a `transposition of photographs in *The Age*' in which a photo of Ballantyne was wrongly labelled as being of Pitt.

1/4/3 9 June 1952

From Pitt to The Secretary, Melbourne & Metropolitan Tramways Board

Pitt complains about the conduct of conductresses and concludes `that the public can only be safeguarded against the treatment I have referred to by replacing the girls by men . .'

1/4/4 20 November 1952

From K.J. Binns (Under-Treasurer & State Commissioner of Taxes, Tasmania) to Pitt

Humorously disputes the claim made in an Ian Potter & Co. newsletter that, `The rate of interest plays an important part in determining the volume of savings.'

1/4/5 27 November 1952

From Pitt to K.J. Binns

Playful response to Binns' `outbreak', in which Pitt suggests he `go down to the Derwent to shake off some of your pre-Adamite fallacies . . .'

SPEECHES & REMINISCENCES

These pieces are not dated, but, with one exception, all appear to have been written by H.A. Pitt.

Two copies of a typed extract from 1931 letter addressed to `Dear Bubbles' (see 1/1/1), beginning, `On arriving at Canberra next morning

. . .'

- Typed transcript of a speech entitled, *The Straight Path*. The `Straight Path', according to Pitt, is one along which protectionism is disbanded, the money market deregulated and the affairs of public utilities are conducted `on business lines'.
- Handwritten, self-deprecating reflection on Pitt's mediocre sporting history. Beginning as a straightforward first person narrative, it suddenly adopts the tone and form of a mock interview.
- 2/4 Handwritten transcript of a speech covering similar ground as 2/3, in which Pitt declares `I think I can without boasting describe myself as a mediocrity of the first magnitude.'
- 2/5 *Memories That Bless*, a eulogy for Mark A. Pitt (Henry Arthur Pitt's father, see 5/1 for photo), written by one of his former school students.

BUSINESS PAPERS

These documents can be divided into two distinct groups, the first relating to Pitt's association with the firm of Ian Potter & Co., the second to his deceased estate.

3/1 Papers Relating to Ian Potter & Co.

3/1/1 Handwritten draft of `Memorandum of Terms of Proposed Partnership Arrangement between Mr H.A. Pitt and Mr W.I. Potter'.

3/1/2 Later, handwritten draft of partnership agreement between Pitt, Potter and James Hias McColl.

3/1/3 Typed `Articles of Partnership', dated 1946, in which it is outlined that Potter owned four sevenths of the firm, McColl two sevenths, and Pitt one seventh. It also states that `the business of the Firm is that of Stock and Shares brokers.'

3/1/4 `Memo of interview between Mr Phipps (a Senior Officer) and Mr Watling (Assessor) of Taxation Office Melbourne, and H.V. Sampson on Wednesday afternoon, 20th November, 1950.'

This document, written by H.V. Sampson and dated 30 Nov. 1950, details a meeting between Sampson and the Taxation Office, in which the status (i.e. private or public) of an unnamed company is discussed. The only obvious connection to Pitt is that `the rise of the firm Ian Potter & Co.' is mentioned as an aside.

3/2 Papers Relating to H.A. Pitt's Deceased Estate.

H.A. Pitt's son, John A. Pitt, was executor to the Will and all correspondence relating to the Deceased Estate is addressed to him.
