HISTORICAL NOTE:

While a Printers' Association was established in Victoria during 1855, the P.A.T.E.A.V. traces its origins back to the Victorian Master Printers' Association formed in the early 1880s. In its early years, it dealt primarily with setting price registers to regulate price wars amongst competitors as well as setting standards in production. During the twentieth century, the Association expanded to include employers in ancillary trades.
