**HISTORICAL NOTE:** This collection contains records of 204 companies liquidated in the year 1953. The *Companies Act 1910* required liquidators to deposit records of liquidated companies with the Registrar General. Records were to be retained for five years after liquidation then destroyed. It would seem that destruction of these records was overlooked. They were transferred to UMA by the Public Record Office of Victoria.

**DESCRIPTION:** Minutes, accounts, correspondence, memoranda and articles of Association etc of companies that became defunct c1953.

**NOTE ON LISTINGS:** Each company has been given a series number. No formal arrangement was found in the records and they have been allocated an item number within the series. The label "not held" indicates that an item listed on a folder in the records was not found. A page index to companies is at the end of the list.
