| HISTORICAL NOTE | The company originated in Hobart in November 1853 as William Crosby and Co. Its early operations involved the shipment of primary products from Tasmania to England and it acted as agents for a number of vessels trading between the two countries. Exports included a wide range of general provisions, including ventures in liquor, meat, grain etc. and wool. In 1858 a branch was opened in Melbourne and it acted in a similar capacity to that in Hobart. In 1926 William Crosby and Co. Pty Ltd was incorporated with its Head Office in Melbourne. Later operated from 488-90 Collins Street. Its 20th century operations included shipping phosphate from the Pacific Islands to Melbourne and Adelaide fertilizer manufacturers, and plying trade routes between Japan, Mauritius and South Africa. In 1973 it was taken over by Oce-Australia Ltd. |
