GENERAL NOTE: The Housing Commission, Victoria (HCV) was constituted on 1 March 1938, the personnel being Messrs. J.N. O'Connor (Chairman), F.O. Barnett W.O. Burt, and Miss F.E. Penington. The Commission conducted a competition for the design and planning of low-cost housing. One of the objects of the competition was to select from among the entrants a panel of architects, to advise the Commission and to undertake designing and planning work. As the first Annual Report put it, "the panel system not only avoids the employment of a large architectural and drafting staff, but ensures to the Commission the variety of the advice and assistance of professional men in private practice".

On 1 June 1939 the following were appointed members of the Architects Panel: Frank Heath, A.C. Leith, Best Overend and J.F.D. Scarborough. During the next twelve months, Messrs. Buchan, Laird and Buchan, of Geelong, were appointed architects for the HCV's provincial housing schemes. During 1941-42, Leith went away on active service, and Harold E. Bartlett (HB) took his partner's place on the Panel - a place which he retained when Lt.-Col. Leith rejoined the Panel in 1943-44. T.J. Buchan also joined at this time.

During 1942, the HCV took over the concrete wall plant of the late T.W. Fowler, and towards the end of the war were gearing the Fowler System of construction for mass production. This was facilitated when the Commission took over the Commonwealth Munitions Annex (Tank Factory) at Holmesglen in 1946. The HCV's Concrete House Project is the subject of a small amount of material in this collection. Other wartime facilities were turned to the postwar housing effort with the development of a prefabricated steel house by the Beaufort Division of the Department of Aircraft Production. Material on this development is also to be found in the collection.

Despite these developments, and the setting up of pre-cutting depots for local timber housing, shortages of materials and labour continued to confront the Commission - to the extent that it became necessary to inaugurate a project of importing prefabricated houses from overseas. Enquiries to this end were initiated in 1949, when Best Overend conferred with several firms in the U.K. and Europe. It is to this project that the bulk of the present collection relates.

Tenders were invited in January 1950 "following strong representations by the Commonwealth Government that the various states should enter into contracts for the purchase of imported houses to supplement the local building programme". At that time, HB was abroad with the Housing Mission sent by the Commonwealth.

The imported house project, at its peak in the years 1951-53, presented unusual problems of organization. The negotiation of contracts in this situation was in itself difficult. These negotiations were carried out by the Panel with a large number of contractors, of whom six signed contracts, but of whom only three (Thermo, Peeman and C.I.B.) actually delivered houses. Those contracts which were carried out presented the Panel with further unfamiliar problems of supervision, shipment and storage, and involved the appointment of consulting engineers in London with supervisors in a wide variety of European and U.K. factories. As the Panel recalled in 1954, "This work was undertaken by the Panel without extra fees and proved to be a very unprofitable phase of the work for the Panel. In only one case did the foreign contractor establish an efficient building organization in Australia to erect the houses on arrival, and the Panel, therefore,...undertook the re-organization of the work in Australia".

As Chairman of the Panel, HB devoted his whole time to HCV work (as did his deputy whenever HB was absent). By the mid-1950s, this work was of four main types: traditional construction in brick, brick veneer or timber; "Transfab." houses of timber which were prefabricated and transported in sections to their final location; concrete houses produced at the Holmesglen factory; and the erection of imported timber houses. In the early fifties, too, the Commission also undertook to build the Olympic Village for the 1956 Games, involving the provision of 700 dwellings on its Heidelberg Estate (one of a number of estates throughout Victoria being developed by the HCV).

The Architects Panel was discontinued during 1955-56 (there had been a Royal Commission at that time into Victorian housing and the administration of the HCV) and its work taken over by architects appointed to the Commission's staff. In 1954, the personnel of the Panel was much as it had been ten - indeed 15 - years before, viz. Overend (Deputy Chairman and Secretary), Leith, Heath and Scarborough (the four inaugural members), plus HB (Chairman), Buchan and E.C. Laird.
