PROVENANCE NOTE:

Deregistration proceedings against the ABCE&BLF officially commenced in September 1985 with an Application pursuant to the Building Industry Act 1985 by the Australian Government Solicitor to the Australian Conciliation and Arbitration Commission. Proceedings officially closed on 4 April 1986 with the decision of the Full Bench of the ACAC.

There had nevertheless been several previous attempts by both State and Federal Governments to rein in the activities of the BLF, as well as corruption charges against its most famous official, Norm Gallagher. Action continued against the Union as a consequence of the ACAC decision.

The Transcript contained in this collection is of the official case to determine whether the BLF should be deregistered. For the broader events leading up to this case and following it, researchers should consult the Brian Boyd Collection held by University of Melbourne Archives.
