HISTORICAL NOTE	<p>The Australian Foremen Stevedores' Association [AFSA] was registered in 1941 under the Commonwealth Conciliation and Arbitration Act 1904, It developed from the Sydney Foremen Stevedores' Association, a union that had been in existence since 1939. The Victorian Branch was formed in February 1945. The AFSA was created to differentiate its members' job functions from those of the Waterside Workers' Federation [WWF], an organisation with which, during the 1940s, it found little in common. The WWF had opposed the AFSA's existence and the difficult relations between the two prevailed. The AFSA was affiliated with the ACTU, the Australian Labor Party and, in 1950, with the Melbourne Trades Hall Council. In 1991 it amalgamated with the WWF and, combined, continued to be known as the Waterside Workers' Federation which later amalgamated with the Seamen's Union to become the Maritime Union of Australia.</p>

GENERAL NOTE: These records provide interesting material for the period 1945 to 1970 concerning working conditions on the Melbourne waterfront: firstly, relations between the Australian Foremen Stevedores Association and other waterfront unions such as the Waterside Workers' Federation and the Seamens' Union; secondly, between the Association and governmental bodies - the Melbourne Harbour Trust, the Australian Stevedoring Industry Authority and the Arbitration Commission; thirdly, between the Association and Melbourne shipowners' associations - the Commonwealth Steamship Owners' Association in the 1940s and 1950s, the Shipowners' State Committee in the 1950s and the Association of Employers of Waterside Labour in the 1960s; and fourthly, the Association's relations with individual shipping companies - Howard Smith Ltd, William Holyman and Sons Pty Ltd, F.G. Strang Pty Ltd, E.P. and A. Fraser, the British Phosphate Commission.

The industrial negotiations of this union are in the form of written or verbal agreements between the Association and shipowners' and employers' organisations, of awards and decisions of the Arbitration Court concerning wages, workers' compensation and Long Service Leave, and of orders issued to various ports by the Australian Stevedoring Industry Authority. The Authority has played an important role, too, in instigating inquiries into general conditions, industrial safety and the effect of strikes on the waterfront.

There is material, also, on the union's involvement with the Victorian Trades Hall Council, the Australian Council of Trade Unions and an association of waterfront unions, the Maritime Unions Council, and with one political body, the Australian Labor Party. This collection contains Minute Books, membership records, correspondence, circulars and reports, newspaper cuttings and printed material.
