HISTORICAL NOTE	Henry Taft was born Grisha Tafypolsky in 1879 in Russia. He emigrated to Australia in 1906 where he founded a stationery business in Collins Street and specialized as a fountain pen retailer and repairer. Taft was joined in partnership by his brother, Misha, who arrived in Australia from the United States three years later and eventually assisted the rest of his family of seventeen to come to Australia. The Taft family also established Merino Knitting Mills and Hillcrest Trading Co. The stationery business continues at the same address, though under different ownership.

A Brief Introduction to the Collection

Harry Taft was born Grigory Abramovich (son of Abram) Tafypolsky in Wernersdorf, Russia in 1879 where his name was abbreviated to Grisha. The Ukrainian pronunciation was Hrisha and this translated into Yiddish as Hirsh. The obvious English translation was Harry Taft.

In 1906 when Grisha came to Melbourne from the Ukraine he spoke very little English but soon established a stationary shop in the city with a partner named Rosenfield. In 1911, they moved the shop to its present location on the corner of Centreway and Collins Street.

Grisha had been joined in Melbourne in 1909 by his brother Misha who had intended originally to settle in the United States. Another brother, Isaac, arrived in 1910. On a return trip to Russia to wind up his affairs in that year, Grisha married Olga Mushatsky who left her home and family to join her husband in a far away land.

Grisha went to Germany and investigated a new device - the fountain pen, which he then decided to import to Australia and sell in his business. He also sold various other products such as ladies handbags in the 1920s and watches in the 1930s.

In 1912 Isaac was kicked by a horse and subsequently died. The following year, 1913, Grisha and Olga's first son, Boyard Israel Taft was born. Their only daughter, Tamara Golda was born in 1919 followed by another son, Ronald born in 1920.

Grisha's parents, Abram and Sara, were brought to Australia from Russia in June 1922 as well as 14 other members of the Tafypolsky family. Soon after these members of Olga's family joined the Taft's in Melbourne. Hillcrest Hosiery, a hosiery factory was established in order to provide some employment for family members.

Harry, as he was soon known, was an active man in the community. The collection indicates the breadth of his interests ranging from his religious involvement in various Jewish organizations, sporting clubs (bowls in particular), the Masonic Lodge, charities and of course his business affairs. Apart from financial statements, balance sheets and asset assessments, the collection also houses aspects of Harry Taft's personal papers including letters, essays, photographs, correspondence, travel documents and certificates etc.
