The letters relate to land dealings during the 1880's and in particular, to the following four transactions:

- Sale to the Railways of approx. 160 acres at Kensington owned by J.R. Murphy. Thomas Bent, Commissioner for Railways. 12 May - 8 Nov. 1882
- Purchase of land at Ferrars Street, South Melbourne, by syndicate including Thomas Bent, George Swinburne, David Munro, Thomas Brentnall, William Benson and H. Andrews.
 June - 1 Nov. 1888
- 3. Sale of "Strathallan" to Hon. C.H. James, M.L.C. at £140 per acre. The property was owned by Mr. Malcolm McLean (resident in Scotland) and comprised some 1670 acres north of Heidelberg intersected by Plenty Road. Letters allude strongly to the financial situation in Melbourne and discuss the different methods of selling used according to the state of the land market.
