HISTORICAL NOTE	Born in Zeehan, Tasmania, Clarrie O'Shea rose to leadership in the Metropolitan Tramways and Omnibus Employees' Association during the 1950s. A committed communist, he moved towards the Peking-leaning Communist Party of Australia (Marxist Leninist) after the 1963 split, later becoming Federal President, and secretary of the Victorian Branch of the Australia-China Friendship Society. In particular, as a unionist, O'Shea was jailed following his refusal to comply with orders under the penal provisions of the Conciliation and Arbitration Act in 1969, sparking nation-wide strike action. In the event although not repealed the provisions of the act were emasculated.

Historical Note:

Clarrie O'Shea began his working life in the early 1920s as a clerk at the Labour Call offices. In the late 1920s he began working at the Coburg depot of the tramways as a tram driver and conductor. At an early stage in the tramways he became involved in the union, and he spent the larger part of his working life as Victorian Secretary of the Australian Tramways and Omnibus Employees' Association (ATMOEA). His union career progressed as follows:

- . North Melbourne Depot delegate, 1932-36
- . Essendon Depot delegate, 1937-42
- . Federal Secretary ATMOEA, 1942-44
- . Federal President ATMOEA, 1947-70
- . Victorian Secretary ATMOEA, 1947-70
- . Life Member ATMOEA, 1971

From early in the 1930s, O'Shea began to study communism and joined the Militant Minority Movement, a communist inspired movement within the trade union movement. The Spanish Civil War 1936-1939 influenced the formation of his political beliefs. By the time he became Victorian Secretary of the ATMOEA he was a committed Marxist-Leninist, and at a slightly later stage he became a Maoist. He continued to take an active interest in communism, and especially Chinese communism, until his death. He was a member of the Communist Party of Australia until, along with other members, he resigned in 1963 and formed the breakaway CPA (Marxist-Leninist). He resigned from that organization in 1981, alleging that like the original CPA it had become revisionist. At that point he became a founding member of the Committee in Defence of Marxism/Leninism/Mao Tsetung Thought. To his death he was concerned with re-establishing an Australian Communist party.

O'Shea's militant leadership of the ATMOEA witnessed prolonged and precedent setting strikes and battles. The most prominent of these were:

1, the one man bus dispute(s) (1954-66), where at various stages the Melbourne and Metropolitan Tramways Board threatened elimination of conductors on the Footscray, Port Melbourne, Garden-City-Bulleen, Fisherman's Bend-City, North Fitzroy, and Point Ormond routes where 60 seater buses had been replaced with 41 seater buses. Union members struck in protest, and, under a bans clause on strikes which had been inserted into the Conciliation and Arbitration Act some years earlier, fines were imposed on the union for each day they struck. This(ese) case(s) ended up in the Commonwealth Industrial Court and then the High Court, with the High Court eventually awarding in favour of the Union. Conductors were retained on the routes until 1981.

2, the Pesteranovic Case (1968-69), where the union put blackbans on co-worker Pesteranovic because he refused to join the union, and the Commonwealth Industrial Court subsequently attempted to prohibit workers' blackban clauses in the ATMOEA Award.

3, the penal powers case (1969), where O'Shea in role as union secretary was jailed briefly for contempt of court which had arisen out of the Union's refusal to pay union fines incurred in the Industrial Court during the the 41-seat bus dispute two years earlier. O'Shea was quickly released upon the intervention of Government.

4, the Barbara Biggs dispute (1973), where co-worker Biggs refused to join the union and the ATMOEA struck.

In a cold war environment, communist leadership of the ATMOEA and the simultaneous assertion of right-wing influences (the industrial groups) within the union movement led to many internal ATMOEA executive and rank and file divisions. Tramways workshops and depots were centres of political activism and dissension throughout the 1950s and 1960s. Clashes in political ideology continued to cause internal ATMOEA rifts until O'Shea's resignation in 1970. His protege and successor as Victorian Secretary, Des Shooter, was also involved in many internal splits during his leadership. These included the development of a rank and file opposition, especially in the Fitzroy North and South Melbourne tramway depots, which contributed to Shooter's forced resignation in 1981. He was replaced by an opponent, Jim Harper. A consequence of these divisions was fiercely and bitterly contested union elections, as some of the records reflect.

Along with material concerning the above, the union aspect of O'Shea's collection also consists of conciliation and arbitration, correspondence, and rank and file material (especially militant depot publications and counter attacks from industrial groupers within the union).

Clarrie O'Shea has been one of the longest-serving and most militant post-war union leaders, and the ATMOEA has had one of the most turbulent post-war union histories.

As the records reflect, O'Shea had a multitude of other interests, mainly political and all closely related, outside his role as union leader. He was specifically interested in communism, and in the various countries with communist regimes, especially China. From 1974-80 he was secretary of the Australia-China Society. He was involved with various left-wing groups in Australia, such as the Australian Independence Movement. Throughout his retirement he involved himself in some labour matters such as opposition to the deregistration of the Builders Labourers' Federation. In this cause he saw parallels with the 1969 penal powers dispute. He was also interested in industrial, educational, and cultural matters generally. The subject files consist of journal and newspaper articles and cuttings, manuscript notes, and pamphlets.

There is also an amount of personal material, including correspondence, some of the most interesting of which details his political rift with Ted Hill, Secretary of the CPA(M-L), in 1981. There are four interviews about O'Shea's life or aspects therein. Finally, the collection contains O'Shea's jottings, talks, and other manuscript notes and autobiographical data, some diaries, and some financial material.
