HISTORICAL NOTE:

Operative Bakers established an industrial organisation in Victoria in 1862. At first the organisation operated under the name of the United Journeymen Bread and Biscuit Bakers' Society of Victoria, assuming the name Operative Bakers' Society of Victoria in 1888. Around the time of the First World War the Union joined the Baking Trade Employees' Federation of Australasia, become this organisation's Melbourne Branch. After the War the Union broke with the federal body and reformed as the Operative Bakers' Union of Victoria. Branches of the Union operated in Melbourne, Ballarat, Bendigo and Geelong. Mildura also had a small Members in this region were known as the Sunraysia Group and membership. came under the jurisdiction of the Head Branch in Melbourne. Operating as a benefit society, the Union has provided services to its Membership in the way of assistance in finding employment Idle Pay, Strike Pay and Christmas Donations to unemployed and retired Members. The Bread Trade Wages Board covering Operative Bakers was established in 1896. The major industrial issues tackled by the Union have been a campaign to shorten hours (an eight hour day was won and lost several times around the turn of the century), and an associated campaign to limit baking to six days a week. At least two attempts were made to establish formal links with Victorian Bread Carters: one in 1920-22 when a committee was formed for the purpose of establishing One Union for the Flour Industry, and the second in 1944-50 taking the form of a Bread Trade Employees Combined Committee. Despite the obvious connections between the occupations of Operative Baker and Bread Carter, the organisational structures representing them have remained separate. In 1975 the Operative Bakers' Union amalgamated with the Pastrycooks Union to form the Pastrycooks. Bakers, Biscuitmakers and Allied Trades Union.
