HISTORICAL NOTE	In July 1890 in response to a public outcry regarding a destitute war veteran who had been committed to prison for reasons of homelessness, a provisional committee was appointed by the Victoria Barracks. The committee created an enquiry board to consider claims for relief and arranged for a public meeting. Subsequently through public subscriptions and a Government land grant of six acres of land at Drysdale, Victoria, a home for the relief of selected needy war veterans was opened on 1 July 1891. Over the next 27 years, with the aid of extension some 105 aged veterans were housed. In 1918 a movement was made to have the responsibility and assets of the Home transferred to the Commonwealth Government who latterly declined. After desultory letting of the property at a very small rental it was agreed during WWII between the Trustees and the Victorian Government to sell the property, with the difference above the land value being paid to the Trustees.

GENERAL NOTE: In July 1890, as a result of public conscience being finally aroused by the committal to prison, solely to ensure his maintenance, of a war veteran of good character, a provisional committee appointed by Victoria Barracks met, appointed an enquiry board regarding claims for relief and arranged for a public meeting. Thereafter subscriptions of some £1,800 were received plus, after a Government grant of some six acres of land at Drysdale, Victoria, substantial furnishings etc. therefor, and a home for the relief of selected needy War Veterans was opened 1st July 1891, commencing with eight inmates. Over the next 27 years, with the aid of some extension and improvements being made, some 105 aged veterans were housed, several deaths took place, and a section of the Bellarine General Cemetery was allocated and the graves cared for. About 1918 a movement was made to have the responsibility and assets of the Home transferred to the Commonwealth Government. The latter declined to accept such transfer. The following decade appears to have been somewhat stagnant, with few veterans living in and only a limited number receiving small amounts of relief weekly. After desultory letting of the property at a very small rental it was agreed in the World War II years between the Trustees and the Victorian Government to sell the property, with the difference above the land value being paid to the Trustees. The last two years accounts in hand (1945 and 1946) do not have an annual report attached and no such sale is indicated. The 1947 financial statements indicate continuance till then of the holding of Government and semi-Government securities to the face value of £4,700. It does not appear, amongst the records received, whether the Defence (or some other) Department has taken over the Trust or Whether the Trustees continue to hold the assets of the Trust under the latest Trust Deed referred to dated 9 December 1941, executed when the sale of the realty was in contemplation. Various famous service names appear among sponsors and office bearers.
