#### Note on the collection:

This collection consists of material gathered by Laurie O'Brien and Cynthia Turner while researching the history of medical and other social work in Australia. The material was collected with the assistance of the Australian Association of Social Workers [AASW] on the understanding that it would be lodged with the University of Melbourne Archives.

The material includes copies of various papers and articles on the theory of social work from the 1850s onwards and files from the Victorian branches of two social work professional associations and their attendant training institutes and registering bodies. These were: the Victorian, later Australian, Association of Hospital Almoners [VAHA; AAHA] with its precedent Victorian Institute of Hospital Almoners; and the Australian Association of Social Workers [AASW] with its association with the Board for Social Studies.

These bodies were separately founded on a state basis, later federating on a national basis, and amalgamated during the early 1950s. The AASW was registered as an industrial organisation in November 1955. In 1976 there was a further change when the industrial functions of the AASW were subsumed in a new, more broadly based organisation of welfare workers, the Australian Social Welfare Union [ASWU], with the AASW continuing but focussing on professional issues for social workers.

The collection has been listed on the basis of the organisation of the material used by Laurie O'Brien and Cynthia Turner, but grouped into portions on the basis of which organisation produced the records. No attempt has been made to arrange the material further at the time of listing.

In addition the collection contains papers and work submitted during almoner and social work courses from the 1930s and a group of material on the theory of almonry and social work from the 1850s onwards.

Some of the files were numbered with an identifying number beginning V . Where so this is noted in the listing between file title and date.
