HISTORICAL NOTE	<p>The Australasian Massage Association was founded in Sydney early in 1905, and another of the same name in Melbourne later in that year. Sharing the objectives of training, examination and registration of members, the two independent bodies amalgamated in March 1906. Training was quickly established in Melbourne, with lectures in anatomy and physiology being given at the University, and soon in Sydney. Masseurs, men and women, were much in demand during the War and a Registration Board was established in Victoria in 1923. The Association, with Branches in all States, seeks to represent and promote the professional interests of its members.</p>
