HISTORICAL NOTE	<p>Registered in England during 1894 as The Australian Estates & Mortgage Co. Ltd. with its Australian head office in Melbourne, the company acquired by takeover assets in New South Wales and Queensland formerly held by the Union Mortgage and Agency Co. of Australia Ltd. Operations extended to sugar, wool, livestock and property selling, together with merchandising, insurance and general agency work in all eastern Australian states. The present name was adopted in 1936.</p> <p>One of the most prominent and certainly the longest serving executive was G.S. Colman, the Australian General Manager from 1928-1969.</p> <p>William Taylor was also a director of the company, and when he died in 1903, the company ran his estate in trust. Taylor had interests in various properties, including Overnewton at Keilor (and now the site of Taylor's Lakes in Victoria), Euston on the Murray River, and Manfred, Garnpang, Salisbury Downs, and Bootra, all in NSW.</p> <p>The collection consists of two major sets of records: various correspondence series between the London and Melbourne offices of Australian Estates, and various papers, including comprehensive and telling financial papers, from each of the properties in which Taylor had interests. For full benefit from the latter set of records, one ought to use the series conjunction.</p> <p><i>In 1884 the business William Sloan & Co. (est. in Melbourne in 1858) became the Union Mortgage & Agency Co. of Australia Ltd (UM&A). The firm's domicile was transferred in 1886 to the UK, where a new company under the same name was formed and the old company liquidated. Originally wool and produce-selling brokers and stock and station agents, it moved into the sugar industry. In 1894 a subsidiary Australian Estates & Mortgage Co. Ltd was established (AE&M). UM&A amalgamated with AE&M in 1899 with the former going into liquidation. The AE&M sugar business expanded in 1924 when the Amalgamated Sugar Mill Ltd was formed. This company was gradually taken over by Australian Estates. In 1936 AE&M changed its name to Australian Estates Co. Ltd (AE). After World War 2 it underwent extensive expansion and growth. AE was taken over by CSR Ltd in 1975.</i></p>
