HISTORICAL	The federal Australian Nursing Federation (ANF) formed in 1924 as a body representing nursing organisations in all states. In 1948 the ANF came under pressure to include economic and industrial objectives into their aims as well as their educational ones. The ANF therefore revived the quiescent Trained Nurses Guild from Victoria, and until 1970 there were two national nursing bodies operating together - the old ANF (which took the Royal prefix in 1955 and abandoned it c.1990) and the Guild for industrial matters. The Guild underwent several name changes until finally amalgamated with the educational body to form the new Royal Australian Nursing Federation between 1970 and 1972.

NOTE ON LISTING		Federal Office initially deposited its records with the Archives of Business and Labour (now the Noel Butlin Archives Centre) at the ANU. They were held in their original order until the RANF withdrew them in 1978. The older Federal records were subsequently resorted into the subject classifications of the then current office system, microfilmed and culled. The remaining paper records were transferred to the University of Melbourne Archives in 1986, while the ANF Federal Office retained the microfilm.
	The index	to the microfilm proved to be inadequate for retrieving the paper records held at UMA. The subject classification did not adequately describe the contents of the files. The original order of the records could not be reconstructed.
	In order	to turn the index into a useful finding aid, files have been redescribed, noting in more detail the parties to correspondence and sometimes the content. An index of organisations has also been created.

Therefore it was sometimes referred to in preliminary correspondence as the Lucy Osburn (or Osborn or Osborne) Scholarship. The scholarship was sponsored by the Bank of NSW. It was to be a biennial scholarship of \$3000 to enable a graduate nurse in any area of nursing to study overseas. These files cover matters such as the establishment and advertising of the scholarship and selection of the 1968 scholarship winner.
