The CAEP organised the Time's Up Conference in September 1985 and the equal pay tram ride and a chain-on, also in 1985. Both actions commemorated similar actions held in 1969 and 1970. CAEP, along with the Women's Social and Political Coalition (q.v.) and Women's Education and Employment Victoria, set up Unfinished Business (q.v.) with funding from the Women's Trust in 1986.
