"Mr. Barker.....does not believe the W. A. government will give us what we ask". Barker says "it is as fine a country as Victoria". Subscribers now 119 of which 55 paid up.

9. Letter Edward Tanner, Winchelsea, to Hugh Murray.

Discusses merits of purchase or charter of a ship, proposes neither and suggests freighting the stock to Camden - preferably by one Mr. Hart. Wants to get on permanent committee of the Association. Mentions agreement between self and T. Murray. Scheme at present too Utopian - "too much of French frivolity and not enough of real English hard thought and work... don't let anyone feel his success depends upon any one or combination of men, but upon his own strong arm and determined will." Stock should be sheep and not cattle.
