HISTORICAL NOTE	<p>On 3 December 1858 a small group of tradesmen, many of whom were involved in the eight-hours day boon achieved three years earlier, formed the first Committee of the National Trades Hall and Literary Institute and the first trades hall was erected in Melbourne in 1859 (records from this period are at the State Library of NSW) . By 1870 the Committee had decided to replace its original building with one suitable as a 'parliament' of the working-class. The present building was built between 1873 and 1925. From the outset the Trades Hall was to provide a place for the social and educational activities of workers as well as their industrial ones. The philosophy of the early Trades Hall Committee was that education was essential to social progress for workers, hence the Library was given a prominent place in the new building. The Trades Hall Council itself has always been central to the industrial and political aspirations of the labour movement in Victoria. From small, proud but parochial beginnings it has developed to spearhead campaigns on hours of work, wages, long service leave, equal pay and other industrial matters. On the social front it has interests in welfare, youth, conservation and Aboriginal affairs.</p>

DESCRIPTION	<p>The records of the VTHC described here were originally filed within the Council's classification schemes, and were selected for permanent preservation using the VTHC Retention and Disposal Schedule. See appendix 1 for details of the classification scheme and its evolution.</p> <p>The VTHC records documented in this list were created within a filing system which ceased in 1989. The scheme continued to follow the earlier practice of giving a classification number to each type of transaction, and creating a new file every year, for transactions within that number. In this list, the files created in 1985 precede those created in 1986 and so on.</p> <p>The files in this list complete the record series transferred to Archives in 2001 and therefore start at Box Number 401. See Reference No. 2001.0020 for records up to 1984.</p> <p>These records were transferred at the same time as those of Reference number 2010.0052 for the 1977-2010 periods.</p>

Appendix 1

VTHC Records Management System and Finding Aids:

[Annotated photocopies are included in 2001.0026]

The finding aids consist of lists of file titles, referred to as indexes.

The first indexes were written in two books.

Book one is titled "Index filing system: A/B 1958-71". On the verso of the title is written

(A) Index filing system pre-1972 Nos. 1-40 Yrs: 1958-1970

(B) Index filing system pre-1972 Nos. 1- Yrs: 1970-1971

Part (A) is arranged by number - annual single number - , subject and year

Part (B) also has the action officers for each file.

Book two contains the file indexes for 1972-1980.

From 1972 to 1977 inclusive, lists were by file number - annual single number - followed by officer and subject (file title).

e.g. 1/1976: PI Nolan: Westgate Bridge Education Expenses

2/1976: General: National Wage Case...

In 1978, the arrangement changed to file titles listed under first level headings, but still with an annual single number file numbering system. A cross reference to the previous year's file number was also included from 1978.

e.g. File No 1977 93: File No 1978 1: General: ACTU: ACTU – Correspondence, Executive

The index also noted if the file was "New file".

These indexes were photocopied and spiral bound separately by year.

The index for 1981 followed the same arrangement, but was not written in the book. A spiral bound index only exists.

In 1982, the index was typewritten and the classification expanded to second level as well as first level headings. The file numbers were also changed to a decimal format, mirroring the first and second level headings.

e.g. 1.1: ACTU: Committees: Disputes Committee

1.2: ACTU: Committees: Education Committee

Otherwise the arrangement was the same, including the cross reference to the previous year's file number.

This format continued from 1982-1985.

In 1986 the system was overhauled and a subject based classification system was introduced. An alphabetical index of file titles was prepared to be used in conjunction with the list of file numbers. This was maintained on a "kalamazoo" and photocopied annually.

This format continued from 1986-1988 inclusive.

These annual indexes are being entered on to a database on DB/TextWorks. It is called VTHCSS and also includes all non central files held in secondary storage. The database will contain all indexes to 1988 inclusive (to end 1984 at Dec 2006) and will be used to manage the transfer of the records to UMA and as the finding aid to the VTHC Archives for this period.
