| NOTE ON LISTING | The list details a small number of documents, found at Trades Hall during renovations, which date from before 1974 and are therefore contemporary with the first accession. It consolidates Accession Numbers 1991.0013, 1991.0028 and 1991.0030. Originally these accessions were integrated intellectually and, where possible, physically into the first accession. These have since been removed and are now physically separated from the first accession. The original series numbering has remained i.e. where an item fitted into an existing first accession series it had been numbered as a continuous part of the series with a ' $B$ ' added as a prefix to indicate the different accessions. The list which follows therefore has a discontinuous numbering system, but must be read in conjunction with the main published guide to the VTHC records.
