Originally called Women in Transition (WIT), Women and Children in Transition first met 14 June 1978 as a support group for women going through a crisis situation after their marriage had broken down. While WACKIT initially functioned as a self-help group for women who needed information, support and advocacy around the issues of leaving the marital home, whether or not to take the children, fighting for custody, the impact and implications of being a lesbian mother and other related issues, it went on to concentrate on the effect the Family Law Act had on women and how they were treated while going through the Family Court, as well as looking at the level of pensions, the availability of legal aid and taking action on these issues as necessary. WACKIT continued to meet on a regular basis as a discussion, referral and action group until it finally folded in July 1982.
