The Melbourne Wool Exchange Pty Ltd (received with 2006.0121)

Incorporated 22 May 1912 to acquire land and build offices. The Melbourne Wool Exchange property was built at 120 King Street, Melbourne in 1913 and sold July 1972 for \$1,812,500. A meeting of members held 11 December 1972 resolved to wind-up the company voluntarily and this occurred on 11 December 1972. The final meeting at which members were advised of the distribution of assets was held on 25 July 1973.

The National Council of Wool Selling Brokers of Australia (2006.0128)

The Association was established in Sydney c1918 as the Federated Wool Selling Brokers of Australia with a membership comprised of wool brokers in Australia. The Council re-located to Melbourne c 1980.

The George Aitken Pastoral Trust created in the University of NSW was administered by the National Council of Wool Selling Brokers until it ceased operating.

The Melbourne Woolbrokers Association (1979.0178)

The Association was formed by the major Melbourne wool brokers around 1897 to regularise wool trading, setting out rules and standards to be maintained. The foundation members of the Association were: Goldsbrough Mort & Coy Ltd, The Australasian Mortgage and Agency Coy Ltd, New Zealand Loan and Mercantile Agency Coy Ltd, Dalgety & Coy Ltd, The Union Mortgage and Agency Coy of Australia Ltd, Younghusband & Coy Ltd, Victorian Farmers' Loan and Agency Coy Ltd and National Wool Coy of Australia Ltd. The Association worked in conjunction with country associations established in Geelong, Portland and Albury. Rules, minutes, accounts, statistics, publications

The Victorian Woolbrokers Association

The Victorian Woolbrokers' Association was established in 1976 and acquired the interests of a number of other organisations with which it merged. The association was wound up in 2006. Minutes, statistics, publications, accounts. Includes records of twenty-four regional and local associations.
