Biography

Geoffrey Alan Bell, was born in Melbourne, Australia on February 12, 1944. Bell, who lived with a high level spinal cord injury for 43 years, was an important figure in the development of the disability rights movement in Australia. The movement, which continues today, advocated for self-determination, independence, and equality for people with disabilities. Bell became disabled as the result of a swimming accident in Geelong in 1965 at just 20 years old, and by the early 1970s he was already an exemplar of self-determination: lobbying for disability rights and public awareness. Bell was involved in numerous groups and organisations including: DAF (Disability Action Forum), The Attendant Care Coalition, Action for Community Living and the ACTU (Australian Council of Trade Unions). Bell represented the ACTU on the International Year of Disabled Persons' national committee in 1981. From the mid-1970s until the early 1980s Bell was employed as a welfare officer at the Western Region Community Health Centre, formerly the Trade Union Clinic, in Footscray. Geoff Bell passed away June 10, 2008 aged 64. He is survived by his daughter Amy and his partner from 2000-2008 Mary Burgess.

Scope and Content of Series

The Geoffrey Bell Archive is made up of two series: Third Party Publications and Personal and Professional Papers. Collectively the archive documents the social and political history of the disability rights movement in Australia from the early 1970s until the 2000s.

This series, Personal and Professional Papers, contains materials created and collected by Geoffrey Bell between 1959–2001, and by Mary Burgess in 2015. The series consists of formal records documenting Bell's involvement on various committees, organisations and self-help groups as well as material relating to his personal life and experience with disability. Materials generated and collected by Mary Burgess in 2015 relate to the preparation and contents of the archive.

Items contained in this series include: meeting minutes, agendas, reports and newsletters from various committees and organisations; correspondence, both personal and professional; newspaper clippings; care records; photographs; posters; workshop, training and conference materials; reports and discussion papers; school materials 1959-1964; car information; and instruction booklets for various aids and equipment used by Bell.

The series consists of 71 items held within nine archival units. Prior to accession by the University of Melbourne Archives the collection was arranged into 15 boxes by Mary Burgess. Slight changes have been made to this arrangement of the archive to allow the creation of the two series and to house sequential folders together. Most of the materials were housed in original order in ring binders and labelled according to contents. While the ring binders have not been retained due to deterioration, copies have been made on acid free paper and included with

each item. The original order within each binder has been maintained and items have been titled according to original labels where relevant.

The majority of the items are in fair physical condition. Rusted staples have been removed from files and replaced with plastic clips. Significant newspaper clippings, such as those containing images of Geoff Bell, have been photocopied onto acid free paper and included along with original materials within files.

A significant portion of the material in this series (11 files) was generated during the meetings of the International Year of Disabled Persons Non-Government Organisations Committee, in which Geoff Bell represented the ACTU (Australian Council of Trade Unions). Other members on the committee included: Geoffrey Say, Bill Harwood, Richard Llewellyn, Michael Chadwick, Edith Hall, Graeme Tucker, Rod Warmington, Janne Graham, Michele Castagna, Bill Woolcock, Bob Weston, Don Westaway, Laurie McCredie, John Lovett, Keith Suter, John Pullicino, Elizabeth Couche, Kevin Coombs, Laurie Kellam, Denys Correll, Bob Black, Harold Wilkinson, and Joe Reeve.

Some of the topics addressed within these files and others in the series include: rehabilitation and prevention; education and training; employment, sheltered workshops and open workshops; accommodation, residential facilities and domiciliary support; access, transport and mobility; self-help groups; Aboriginal Australians and disability; law reform; equality; advocacy; activism, and self-determination.

The Geoffrey Bell Archive has been made available due to its historical and research importance. As a historical record some of the material held within the archive may contain language that reflects the era in which it was created and may not be considered appropriate by today's standards. The Collection is a useful resource for researchers interested in the history of the disability rights movement in Australia and may prove a useful aid for future debates and discussions on disability rights issues.
