the said John Doe and his assigns from the 4th day of
March in the year aforesaid for term of years and unto the full
end and term of 25 Years from thence next ensuing and fully to be
complete and ended. By virtue of which said devise the said
John Doe was and became possessed of the said
Negro and other Male & female Slaves and was so thereof
possessed until the said Richard Roe afterwards to wit the
6th day of March aforesaid in the year aforesaid at the
parish of Westminster in the County of Cornwall aforesaid
with force and arms he did take possession of the said
Negro & other Male & female Slaves and him the said John Doe
from his former thereof his term therein aforesaid not being
yet ended did eject expel and remove, and him the said
John Doe being so thereof ejected expelled and removed from
his possession thereof aforesaid hath hitherto out held and
still out holdeth, & other Committed to him then & there did,
against the peace of our Sovereign Lord the King that now
is and with Damage of the said John Doe of

Current money of the Island aforesaid: &
therefore he sues to.

Sir,

You may perceive by the above Declaration in
Court that I am sent for the Last several Negro or other Male &
female Slaves therein mentioned or for some part thereof to which I have
no title; if therefore you claim any Slave and intend to defend it, you
must appear at His Majesty's Supreme Court of Judicature to be holden
at the town of Santa Fe de Bogota, in the County of Nariño, in the
said Island, the first Monday in October next by some attorney of
that Court and make your defence, otherwise I shall suffer Judgment
to pass against me by default, and you will be turned out of possession
