HISTORICAL NOTE	Thomas Turner a'Beckett was born in London on 13 Sep 1808, the second son of a solicitor. He was educated at Westminster School; studied law at Lincoln's Inn and was admitted as a solicitor and attorney in 1829. He practiced with his father in London until he emigrated to Victoria in 1850. In Melbourne he practiced as a solicitor and notary public and served as a MLC for over twenty five years. As a businessman a'Beckett served on numerous boards including the Melbourne and Hobson's Bay Railway Company where he was chairman for more than twenty years. He was also registrar of the Anglican diocese from 1854 to 1887. He died at Brighton, Victoria on 1 Jul 1892. a'Beckett acted as a solicitor on behalf of the Montefiore brothers as their papers show.
