HISTORICAL NOTE	Born in 1867 in London, Harrison Moore spent some time in journalism before proceeding to study law at the Middle Temple, London, and at Cambridge. In 1893 he succeeded Edward Jenks as Professor of Law at the University of Melbourne, and became the third Dean of the Faculty. His interests included the Australian Constitution and the Imperial Federation League, the Round Table and the League of Nations, being prominent in organizing the Victorian branch of the last-mentioned and attending the Conference in Rome in October 1927. He was also a member of the delegation in 1929 and 1930 and was chosen as Australia's representative at the Imperial Conference. He was President of the Victorian branch of the League of Nations Union, Chairman of the Victorian division of the Royal Institute of International Affairs and as a member of the Executive Committee of the Institute of Pacific Relations led an Australian contingent to the Institute's Conference in Shanghai in November 1931. He was a director of Robertson & Mullens in the 1920's and 1930's. He married Edith a'Beckett in 1898. He died at Toorak on 1 July 1935.
NOTE ON COLLECTION	 Due to its high use, the entire collection was transferred into acid-free folders and re-boxed into Type 1 archive boxes. Items in each group were checked and re-ordered to match the lists. Some of the more fragile items were placed in Mylar or other inert plastic sleeves. Item 5/2/7: Covers had fused with loose items, so the notebooks were separated and placed in a plastic sleeve. Documents had to be cut away (with no loss of text). Item 6/5/5, listed as "Constitutional Changes during the Peace Conference', is actually a reprint from The Times entitled "The Dominions and Foreign Policy', Feb 1925. Listed items 1/2/42, 6/5/4 and 10/2/24 appear to be missing.
